

**NOTICE OF ADDITIONAL 15-DAY PUBLIC COMMENT PERIOD FOR

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect, The Office of the State Fire Marshal, The Office of Statewide Health Planning and Development and the Department of Housing and Community Development, is providing notice of code changes intended for the 2022 California Building Standards Code that were the subject of written comments from the SD/LF - BFO initial 45-day public comment period that began on September 3, 2021, ending on October 18, 2021.

CBSC will accept written comments for at least 15 days between **November 1, 2021, through November 16, 2021**. All written comments must be submitted to CBSC no later than midnight on **November 16, 2021**.
